The Monticello Historic Preservation Commission met Tuesday, May 5th at 4:00 pm via webconference.

Chairman Hutson called the meeting to order at 4:04 p.m. The minutes of the February 4, 2020 Historic Preservation Commission meeting were presented for approval. Callie gave an update on the website. The North State St. district has been uploaded. Callie has requested help with additional pictures of the houses in the district, new and old. Bill Helfrich said he has quite a few pictures from when he was on the Commission and he will put them on a thumb drive and drop them off at the city building.

Maynard gave an update on the replacement brochure holders. The brochure holder for the Court House Square has been installed. He will work to get the other holders ordered and replaced.

Under New Business, Keddy discussed the possibility of applying for a Certified Local Government Grant for the plan to utilize the Community Building as the new City Hall and Police Station. With the shutdown of the government awarding grants has been placed on hold for the time being. Terry Summers had contacted Keddy to let us know that in the interest of time, the City would be funding preliminary studies for the Community Building as City Hall and Police Department. It was suggested that the CLG Grant could then be utilized for other approved project costs on down the road. To that end, we will continue to prepare Grant Application materials in order to be prepared when the State Government reopens. Bill Helfrich has volunteered to help with the grant writing process.
