**“AN ORDINANCE DECLARING SURPLUS PROPERTY AND
AUTHORIZING THE PURCHASE OF PROPERTY”**

WHEREAS, THE City desires to dispose of a 2008 John Deere 3520 Compact Tractor (VIN LV35200H451000) and a 2007 Johnson MX450 Street Sweeper (VIN 1J9VM3H697C172139); and

WHEREAS, the City Council of the City of Monticello deems it necessary to purchase a 2022 John Deere 3039 Compact Tractor from AHW and a 2022 Tymco 435 Street Sweeper from EJ Equipment, herein after “New Equipment”; and

WHEREAS, the City has negotiated a contract with AHW in which the City trades to AHW the City’s 2008 John Deere 3520 Compact Tractor (VIN LV35200H451000) for credit against the purchase price of the New Equipment, leaving a net purchase price of \$22,000, and the City has negotiated a contract with EJ Equipment in which the City trades to EJ Equipment the City’s 2007 Johnson MX 450 Street Sweeper (VIN 1J9VM3H697C172139) for credit against the purchase price of the New Equipment, leaving a net purchase price of \$188,700.00.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Monticello, Piatt County, Illinois, as follows:

1. The recitals set forth above are hereby incorporated into this Ordinance and made a part hereof as if fully set forth herein.
2. The City hereby declares the aforementioned equipment to be surplus and authorizes the City Administrator to dispose of and to trade aforementioned equipment to AHW in exchange for a credit against the purchase price to be paid for the New Equipment: 2022 John Deere 3039 Compact Tractor.
3. The City hereby declares the aforementioned equipment to be surplus and authorizes the City Administrator to dispose of and to trade aforementioned equipment to EJ Equipment in exchange for a credit against the purchase price to be paid for the New Equipment: 2022 Tymco 435 Street Sweeper.

4. The Mayor of the City of Monticello is hereby authorized to execute the purchase of the New Equipment as described above in the amount of Two Hundred Ten Thousand Seven Hundred and 00/100 Dollars (\$210,700.00).

5. **Effective Date.** That this Ordinance shall be effective forthwith upon its passage and its approval, and a copy hereof shall be published in pamphlet form by the City Clerk.
