**“AN ORDINANCE DECLARING SURPLUS PROPERTY AND
AUTHORIZING THE PURCHASE OF PROPERTY”**

WHEREAS, THE City desires to dispose of a 2013 Chevrolet Impala (VIN 2G1WD5E37D1128110), and the 2019 Ford Expedition (VIN 1FMJU1GT8KEA43789); and

WHEREAS, the City Council of the City of Monticello deems it necessary to purchase two 2023 Ford Police Interceptor’s from Ridings Auto Group, herein after “New Equipment”; and

WHEREAS, the City has negotiated a contract with Ridings Auto Group in which the City trades to Ridings Auto Group the City’s 2013 Chevrolet Impala (VIN 2G1WD5E37D1128110), and the 2019 Ford Expedition (VIN 1FMJU1GT8KEA43789) for credit against the purchase price of the New Equipment; and

WHEREAS, the City deems it necessary to purchase the New Equipment and aftermarket accessories for this New Equipment in the amount not to exceed \$71,500.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Monticello, Piatt County, Illinois, as follows:

1. The recitals set forth above are hereby incorporated into this Ordinance and made a part hereof as if fully set forth herein.

2. The City hereby declares the aforementioned equipment to be surplus and authorizes the City Administrator to dispose of and to trade aforementioned equipment to Ridings Auto Group in exchange for a credit against the purchase price to be paid for the New Equipment: Two 2023 Ford Police Interceptor’s.

3. The City Administrator is hereby authorized to execute the purchase of the New Equipment and Accessories not to exceed Seventy-One Thousand Five Hundred Dollars (\$71,500.00).

4. **Effective Date.** That this Ordinance shall be effective forthwith upon its passage and its approval, and a copy hereof shall be published in pamphlet form by the City Clerk.
