A Resolution Approving a Strategic Plan for the Years 2023-2026

WHEREAS, the City Council has worked to provide and establish an update to the 2014-2019 Strategic Plan (“Plan”) to guide decision-making and resources allocation; and

WHEREAS, a collaborative effort between the City Council and City Staff, with valued input from many community stakeholders, has been completed in order to define a vision, mission, values and strategic performance areas, intended to advance the City and community towards this vision; and

WHEREAS, performance areas will be utilized to develop budget priorities and establish the City’s operational work plans; and

WHEREAS, in September, 2022, consultants from Northern Illinois University’s Center for Governmental Studies and Egret and Ox Planning conducted individual interviews with members of the City Council and City leadership on their individual goals and objectives for the community’s future; and

WHEREAS, in February, 2023, the City Council and Staff participated in a collective workshop retreat where the goals and objectives for the future of the community were reviewed and discussed, and provided input to be incorporated into the Plan; and

WHEREAS, the Mayor and City Council has reviewed and approved the Plan and its associated components for the years 2023 – 2026.

NOW, THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Monticello, Piatt County, Illinois as follows:

SECTION 1: That the foregoing recitals are incorporated herein as if fully set forth.

SECTION 2: That the 2023-2026 City of Monticello Strategic Plan, including the City’s vision, mission, values, attached hereto as Exhibit 1 is hereby approved.

SECTION 3: That the City Council hereby supports pursuit of the identified performance areas in the Plan through the refinement of work plans that consider evolving priorities and outcome metric trends.

SECTION 4: That the validity or invalidity of any section, part, provision, term or phrase of this resolution shall not affect the validity or invalidity of the remainder hereof.
