6) New Business

a. Ordinance 2013-28 Amending Title III Chapter 30 of the Municipal Code – Consent Agenda & Committee Meeting of the Whole

City Council is interested in utilizing meeting time more efficiently and effectively. This ordinance provides an opportunity to adjust future agendas in such a manner that will allow more opportunities for City Council & City Staff discussion via the use of a consent agenda. This ordinance also allows opportunities for the use of a "Committee Meeting of the Whole" at the end of each City Council meeting.

b. Ordinance 2013-29 Approval of an Ordinance Enacting the Illinois Prevailing Rate of Wages for Public Works

Approval of this ordinance is required each year. The ordinance regulates wage rates for Public Works projects as determined by the IL Dept. of Labor.

c. Resolution 2013-30 Conditional Use – 1402 N Market - Lynn's Family Pharmacy

This resolution amends the original conditional use resolution and allows up to 12 buildings for display & sale, which is a separate use of this property.

d. Resolution 2013-31 Conditional Use - 818 Edwards St – Sean & Sheila Grambart

This resolution allows the owner to construct a pool house for an inground pool on the property. The pool house constitutes an additional accessory structure which requires a conditional use.

e. Ordinance 2013-32 Variance – 818 Edwards St – Sean & Sheila Grambart

This ordinance allows the owner of an in-ground swimming pool to utilize an existing 5' tall fence (Municipal Code requires 6' tall fence) on the west common property line.
